IT GUIDES COORDINATORS ON HOW TO VERIFY ACCOMMODATION APPROVALS FROM THE COLLEGE BOARD AND IMPLEMENT THEM WITHOUT COMPROMISING THE TEST'S INTEGRITY.

- ****CONTINGENCY PLANNING:**** PREPARING FOR UNFORESEEN CIRCUMSTANCES SUCH AS EMERGENCIES OR INCLEMENT WEATHER, AS SUGGESTED IN THE MANUAL'S TROUBLESHOOTING SECTIONS.

BY ADHERING TO THESE PRACTICES, COORDINATORS CAN MITIGATE COMMON PITFALLS AND ENHANCE THE OVERALL TESTING EXPERIENCE.
